SHORT MINUTES OF ORDER dated 18 July 2016.

The Court makes the following orders:

1. An order, pursuant to section 439A of the Corporations Act 2001 (Cth) (the Act), that the period within which the First Plaintiffs must convene meetings of creditors of each of the Second to Forty Third Plaintiffs be extended up to, and including, 31 January 2017.
2. An order, pursuant to section 447(A)(1) of the Act, that the meeting of the creditors of the Second to Forty Third Plaintiffs may be held at any time during the convening period, or within 5 business days of such date, as extended by Order 1 above, notwithstanding the provisions of section 439A(2) of the Act.
3. Liberty granted to the First Plaintiffs to apply to the Court for any further extensions of the convening period referred to in Order 1 at any time prior to 31 January 2017.
4. Liberty to apply to any person who can demonstrate sufficient interest to vary or discharge these orders appropriate notice being given to the First Plaintiffs.
5. An order that the costs of these proceedings are costs and expenses of the administration of the Keystone Group.
